APPLICATION DETAILS

TO ENROLL in the program, candidates must apply to both HBS and HLS separately and must be admitted independently by each.

- Interested HBS applicants can **apply** in either 2 rounds of admission. [↗]
- Interested HLS applicants must **apply** by the February deadline. [↗]
- Prospective JD/MBA students may apply to both schools concurrently, or during the first year as a student at HBS or HLS.

PROGRAM DETAILS

During Years 1 and 2, students complete the core first-year curricula at both HLS and HBS; either may come first. During Years 3 and 4, students take elective courses at both schools and must also participate in a Joint Degree Program Seminar taught by HLS and HBS faculty during one of these years.

After their first year at HLS, students typically spend their summers at a law firm or at a law-related public interest employer. After their first year at HBS, students often spend the summer in a business-related job, either in a for-profit or nonprofit company. After the third year in the program, students choose from a variety of legal and business summer internship opportunities.

With the help of the many resources, workshops, recruiting events and coaching through the HBS and HLS career offices, the majority of JD/MBA graduates take on an MBA level role in a variety of sectors, including Investment Management, Venture Capital, Health Care, and Real Estate. Other graduates join a law firm and some start their own business.
